Verification and security



- To open the document, you will need to input a One Time Security Code that will be sent to the phone number we have for you on our records
- You can request this is sent by text or provided by a phone call
- Input the 6-digit code into the field detailed and click "Confirm Code". You have three attempts before this is locked
- Once completed, you will be redirected to the document
- You will be asked to tick a box to confirm that you agree to use Electronic Signatures

All documents are sent from a Close Brothers employee with a format of firstname.surname@closebrothers.com or firstname.surname@closebrothersam.com or donotreply@closebrothersam.com. You may receive documentation from a member of our support services team. If you are not confident on the sender please do speak to your usual Close Brothers contact to verify or arrange for documentation to be sent via an alternative method.

I do not recognise the last four digits of the contact number used for the Verification step or my telephone number has changed.

Please speak to your usual CBAM contact. We will verify and update our records and the paperwork will be re-sent with the correct contact number. I have entered the Security Code three times and received the following error.



You have three attempts to input the Security Code, if unsuccessful speak to your usual Close Brothers contact who will resend the documentation.

Within three attempts, you also have the option to select "Resend" or "receive a phone call."



I have received a document or a form and it has an error on it. Can I correct it?

Yes, you can delete and replace with the correct information. If others have signed before you it will automatically ask them to resign with the new information.

In order to complete signing select 'View', scroll through the document and select 'Accept' to confirm you have read the enclosures. You will need to read these in order to select 'Accept'.

Select 'Other Actions' or click the three lines on a mobile device then select 'Sign on Paper'.

Download the documentation, print, complete and sign and return via post.
