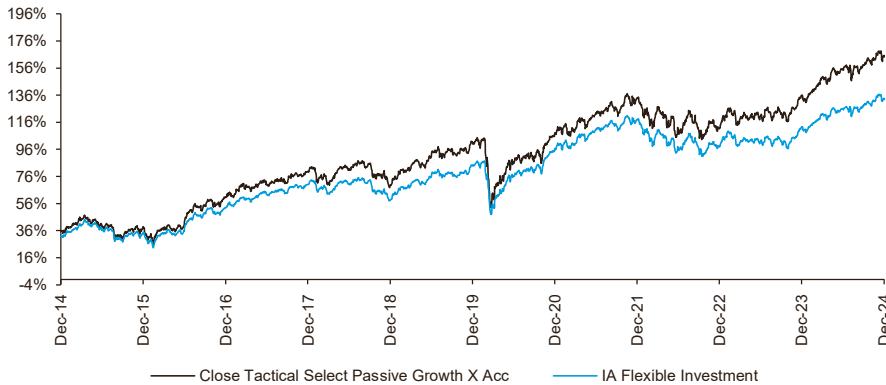
Fund objective

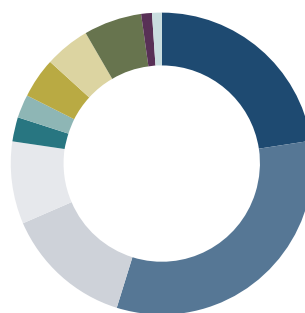
