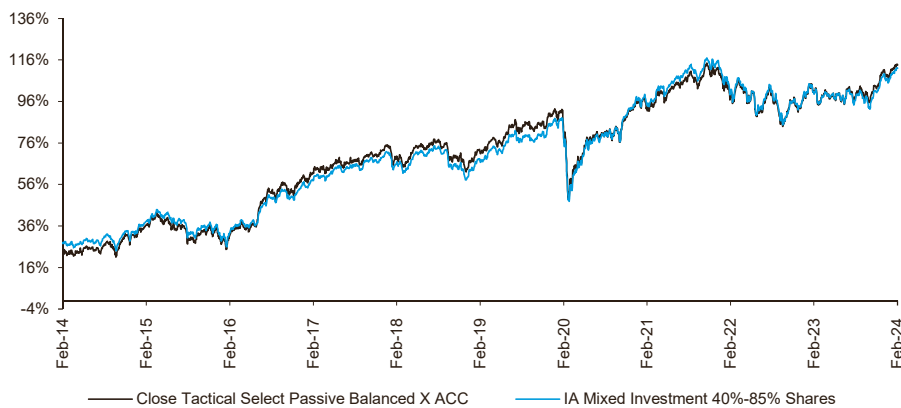
Fund objective

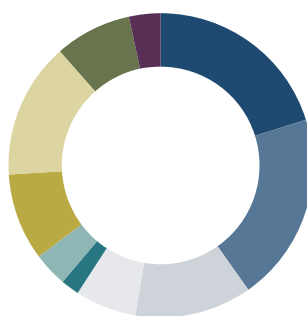
