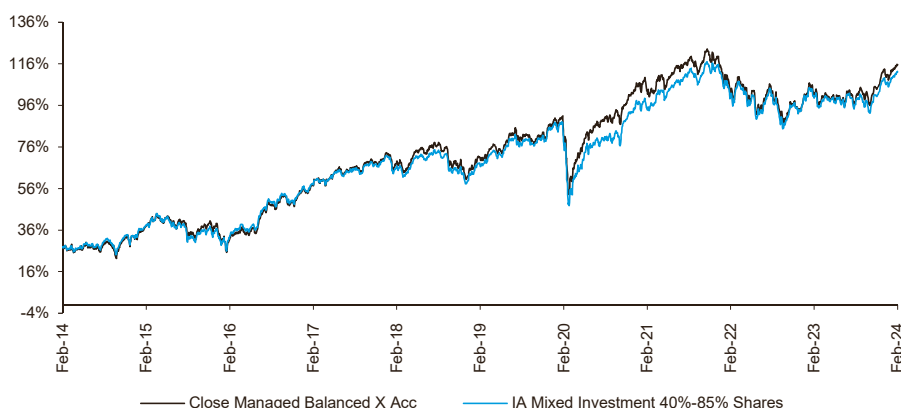
Fund objective

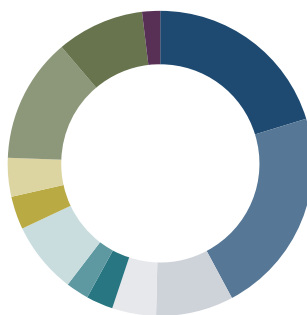
